#### III. Discussion

A. EBC Rate Renewal & 100% Diagnostic Coverage

The renewal meeting took place on March 15<sup>th</sup>. The original projected rates were 9.1% for PPO and 3.2% for HMO. The actual rates came out to 8.5% for PPO and 2.1% for HMO.

It was already agreed that the number 4 option, increasing the deductible, would allow the 100% Diagnostic Coverage to remain.

Options were discussed for the 0.5%. The options to consider were:

#9 - Office visit copay \$30, specialist copay \$50 at 0.51%

#17 - Increase ER copy to \$400 at 0.55%

#7 - Increase office visit copay to \$25, specialist copay \$40 at 0.29%

And

#14 - Increase ER copay to \$250 at 0.28%

The union will discuss and decide at next meeting.

It was asked if we could find out if the clinic down the street bills as office visit or outpatient.

#### B. Membership follow-up

Bev Orozco and Ernie Schmidt are two new members who have joined the committee. One more committee member is needed. Mrs. Germany will send out another request for one more member.

C. District Website – Employee Insurance/Benefit Section Update
